**ORDER**

As per reference cited 1<sup>st</sup> above, Dr. Shibu Vardhanan, Member Secretary, Calicut University Human Ethical Committee (CUHEC) requested to reconstitute the Human Ethical Committee in University since the validity of present Committee is expired.

Human Ethical Committee was constituted in University of Calicut as per Indian Council of Medical Research (ICMR) guidelines and the constitution of Human Ethical Committee in the University enhanced the quality and monitoring of the research works in which human participants are involved.

As per the Standard Operation Procedure (SOP) of the Calicut University Human Ethical Committee, the duration of appointment of the members shall be for a period of three years and at the end of third year the committee shall be reconstituted after replacing 50% of the members.
